The term of the newly constituted Bar Council of Tripura shall expire on 31st March, 2014. Therefore, the Bar Council of Tripura is directed to ensure that elections to the Bar Council of Tripura are positively held well before the said date so that a duly elected Bar Council is constituted on or before 31st March, 2014.

In terms of Rule 12 of the Bar Council of Tripura Rules, 2013 till the aforementioned nominated members elect a Chairman, Vice Chairman and other office bearers, Shri B. C. Das, learned Advocate General shall function as the Chairman of the Bar Council of Tripura.

In terms of Rules 12, 13 and 43 of the Bar Council of Tripura Rules, 2013, the first meeting of the Bar Council shall be held on or before 5th October, 2013 and in the first meeting the Bar Council shall ensure that an Enrolment Committee is formed so that the fresh Law graduates can be enrolled as Advocates of the Bar Council of Tripura.
